

Treasurer's ReportTo: **Downtown Development Authority Board of Directors**From: **Paul Hanebuth**Date: **8/12/19**Re: **July 2019 Financial Reports**

Primary Operating Account: Rent payments were the primary source of revenue during July, totaling \$10,698 from the North Avondale properties. Interest income totaled \$2,252, of which \$2,087 was earned in the Georgia Fund 1 investment account. July expenses included \$1,503 in insurance expense, \$2,550 in legal services, \$1,800 for planning consultants, and \$1,473 in expenses for the fall Wine Walk.

Department of Juvenile Justice (DJJ) Building Operating Account: July expenses included the pass-through payment to MARTA for parking lot rent and the monthly management expenses for the DJJ building. DJJ rent revenue for July was received and booked, though the amount will likely be adjusted when a new lease agreement is finalized. Management expenses for July of \$41,361 will be booked in August.
